**INFORMATION PAPER  
CHANGES WHICH MAY AFFECT ECONOMIC LOSS CLAIMS**

**CHANGES IN AVERAGE WEEKLY EARNINGS**

An Information Paper released by the Australian Bureau of Statistics ("ABS") in November 2008 disclosed with respect to the publication Average Weekly Earnings, Australia (Catalogue 6302.0) some revisions were necessary. As a result, the Average Weekly Earnings ("AWE") data series for the period August 1996 to May 2008 has been amended on a progressive basis.

The definition of earnings used in the AWE survey is broadly, current and regular payments in cash to employees for work done, i.e. the earnings series from the AWE survey have historically excluded amounts salary sacrificed as these were considered payments in kind.

The ABS indicated that although the estimates of earnings from the AWE survey should exclude amounts that were salary sacrificed, in practice there was evidence that the AWE series had inadvertently included some salary sacrificed amounts. The ABS determined that there was some misreporting.

For the period May 2006 to May 2008, revisions have been applied based on the correction of quantified reporting errors made by individual businesses.

Data prior to May 2006 has been revised using factors based on the difference between the published series and the revised series as at May 2006. In this regard, factors have been calculated and applied at the sector by State, by Industry Division level back to August 1996.
